The Chairperson assured her help in getting additional funds of Rs. 329 lacs released at the earliest for the completion of priority buildings and other works to

meet the requirements as prescribed by AICTE and Panjab University.

ITEM NO.3.3 Overall progress report of Shaheed Bhagat Singh College of Engineering and Technology, Ferozepur.

Buildings and Development Works: -

The project report of the college was approved by the BOG in its first meeting held on 9.6.94.

The total outlay of funds for building and development work is Rs. 2422 lacs. The work for construction of buildings providing of services like sewerage, electricity, roads and water supply and creating of other infrastructure was entrusted to National Buildings Construction Corporation Ltd. (A Govt. of India Undertaking) on turn key basis and an agreement was signed on 29.6.94. The construction work of the college buildings was started on 17.9.96.

The college is spread over an area of 98.4 acres and is located on Moga road at a distance of 4 km. from Ferozepur.

A sum of Rs. 134.43 lacs has been paid so far towards cost of the land. Some landowners have since filed cases in the court for enhanced compensation.

The master layout plan for the college provides for a total plinth area of 58002 Sq.metres as per details below:

A sum of Rs.1679.40 lacs has been spent on buildings and development works as on 31.3.97. Besides this there is a liability of Rs. 289.42 lacs against pending bills of January to March, 1997 submitted by the NBCC. Works on administrative complex (3,949 m²) and amenities for students and staff (3,823m2) has not been taken up as yet.

in view of urgent requirements, prescribed by AICTE and P.U., work on one hostel for boys, shopping complex and library building has to be taken up immediately on priority basis. Work on chemical block is to be expedited so as to make at least 25 percent space available by July, 1997 to hold laboratory classes for second year students of chemical and materials engineering. For this purpose funds are urgently required.

Equipment, Machinery and Books:

A sum of Rs. 422.00 lacs is provided in the detailed project report of the college.

An expenditure of Rs. 136.04(including pending liability of Rs. 15 lacs) lacs has been incurred as on 31.3.97 for creating these facilities.

Following laboratories have been adequately equipped and are functional:-

Library:

A total of 4485 text books have been procured for the use of students and teachers. 50 journals/periodicals/magazines and 335 ISI codes/workshop manuals and eleven newspapers are being received in the reading room of the library.

Vehicles:

The college has one ambassdor car, one mini bus (33 seater). Chasis of one big TATA 1510 bus (52 seater) has been received. Jeep (Mohindra) is expected to be received any day.

Academic Programmes:

Admissions to three B.E.degree programmes namely Mechanical Engg., Production Engg. and Industrial Engineering were made through CET - 95 with an intake of 40 students in each. The first academic session was started on 21.8.95 on the College Campus using facilities for holding lecture classes, practicals and workshops. Living accommodation for students and staff was also made available on the campus.

Admissions to all the six B.E. degree programmes namely Mechanical Engg., Production Engg., Industrial Engg., Computer Sc. & Engg., Chemical Engg. and Materials Engg. were made through CET - 96 with an intake of 40 students in each. The academic session 1996-97 started on 1.8.96. Adequate facilities for students hostel (boys and girls), staff residences and for the holding of classes are being created on the campus as per needs.

AICTE approvals for the courses offered in the years 1995-96 and 1996-97 were duly obtained. Extension of approval of AICTE has been received for the courses for the year 1997-98.

Inspection team of Panjab University has also visited the college on 30.8.96 for affiliation of the additional three courses as above. Inadequate provision of funds & delayed release of instalments of grantin-aid is posing a serious problem in meeting our time schedule targets resulting in delays in completion of buildings and procurement of equipment and machinery. This is resulting in adverse observations by AICTE and Panjab University.

During the year 1996-97 the college has started coaching classes to guide the candidates who are appearing in the CET-97 examination.

Staff Recruitment:

A total of 38 faculty members at all levels are in position as on date.

A total of 64 other staff members including technical and ministerial staff are in position as on date.

The details are placed as annexure - II on page 26 to 30.

A total of 47 persons have been deployed on annual contract basis as security guards, malis and sweepers/scavengers to provide required services on the campus.

The delay in the release of budgeted funds is seriously affecting the progress of works on buildings and procurement of equipment and machinery for the laboratories.

The targed completion of civil and development works through NBCC by December, 1997 is certainly behind schedule and is going to result in escalation of the cost of the project by at least 20-25 percent.

ITEM NO.3.4 To report the proceedings of the third meeting of the Finance Committee.

Third meeting of the finance committee of SBSCET, Ferozepur was held on 8.4.97. The minutes of the said meeting were circulated to its members vide this office memo no.SBSCET/FZR/425-431 Dated 28.4.97 for comments, if any. No comments have been received so far. TITEM NO.3.5 The report the appointment of staff (teaching and other saff).

The posts, as provided in the detailed project report of the college, were approved by the BOG of the college in its second meeting held on September 24, 1996 vide item no. 2.7.

The appointments to approved teaching and other posts are made from time to time after following procedure laid down in the college bye-laws. The list of staff (teaching & other staff) is placed at annexure II on page no. 26 to 30.

The proceedings of selection committee are placed at annexure no. III & IV on page no. 31 to 67.

Item No.3.6 Confirmation of staff who successfully completed their probation period.

Rule 2.17(c) of college bye-laws is reproduced as under:

"On completion of period of probation or the extended period of probation as the case may be, the employee shall, if his work and conduct during the period of probation has been satisfactory, be confirmed in the post and shall continue to hold his post till the age of 60 years subject to the disciplinary rules of the college."

The details of the employees who have successfully completed their probation period is placed at annexure VI on page no. 73

The matter is placed before the BOG for approval please.

Item No.3.7 Grant of incentive increments to faculty members on their acquiring higher qualifications.

Dr Rakesh Dogra, Lecturer in Applied Physics and Mr.Sanjeev Kumar Ahuja, Lecturer in Chemical Engg. have represented for grant of incentive increments on acquiring higher qualifications i.e.Doctoral Degree/M.E. Degree. Their cases were dealt as per the Pb.Govt. notification placed at annexure VII on page no. 74 to 86. They were informed accordingly.

The said employees again represented alongwith photocopies of judgement awarded by Hon'ble Punjab & Haryana High Court. These are placed at annexure no. VIII on page no. 87 to 99.

According to the said judgement, the incentive increments shall also be granted to the employee who have improved their qualifications during the currency of their services. Once the law has been laid down it shall not be necessary for the teacher, equally situated to file separate writ petition for identical relief and it shall be enough for them to make representation to the concerned authority with the copy of judgement for appropriate relief.

The matter is placed before the BOG for consideration and decision regarding grant of incentive increments to the teaching staff according to the above referred judgement.

ITEM NO.3.8 Renewal of contract appointment of Prof.R.C.Bahl,
Principal, Shaheed Bhagat Singh College of Engineering &
Technology, Ferozepur.

Prof. R.C.Bahi was appointed to the post of Principal, SBSCET, Ferozepur vide office memo no.2589 dated 22.6.94 copy placed at annexure IX on page no. 99 to 100. He joined his duty on 11.8.94 copy placed at annexure X on page no. 101.

The very first condition of the offer of appointment made to Prof.R.C.Bahl reads as follows:-

"The appointment will be on contract for a period of three years, renewable on the decision and order of the Board of Governors, uptil age limit prescribed by the Rules/Bye-Laws of the college".

As the term of appointment of Prof. Bahl is ending on 10.8.97, the case of renewal of contract appointment was sent to Minister TE & SS & Chairperson Board of Governors through DTE/IT & PSTE/IT vide this office note no.678 dt.13.5.97 (copy placed at annexure no.XI page no. 102.
