The status of action taken for some of the items as required is as below:

Item No.1.5 Transfer of Assets and Liabilities of Shaheed Bhagat Singh State

Technical Campus, Ferozepur to Shaheed Bhagat Singh State

University, Ferozepur.

Decision: The item was further put up in 5th meeting of the Society of SBSCET,

Ferozepur under Agenda item No. 5.03. The Society decided to put the

item in this regard in 2nd meeting of the BOG.

Action: As per the above decision the complete case was put in the 2nd meeting of

BOG vide agenda item no. 2.07 (c), the Board of Governors has decided

as given below:-

"The item was discussed and it was decided that Evaluation Report of the

Assets and Liabilities of Shaheed Bhagat Singh College of Engineering &

Technology Ferozepur Society shall be prepared for handing over it to

Shaheed Bhagat Singh State University Ferozepur and same shall be

taken over by the Shaheed Bhagat Singh State University, Ferozepur."

In this regard a six member committee constituted vide letter no.

SBSSU/FZR/E-3/5924-29 dated 24.03.2022 (Annexure-II, Page No.72)

to prepare Evaluation report of assets and liabilities of erstwhile SBSCET, Ferozepur for the purpose of transfer of assets and liabilities of SBSSTC, Ferozepur to Shaheed Bhagat Singh State University, Ferozepur. The reminder vide letter no. SBS/FZR/E-3/1181-86 dated 13.06.2022 (Annexure-III, Page No.73) was also sent to committee for above mentioned work. The Evaluation work is under process till date. In this regard detailed information is being placed before BOG for information vide agenda item No. 3.25.

"Further, it was also decided that a committee constituted in the 1st meeting of BOG of the University vide agenda item No.1.5 will decide the terms and conditions on which staff of Shaheed Bhagat Singh State Technical Campus, Ferozepur will be taken up in Shaheed Bhagat Singh State University, Ferozepur."

As per the above decision the meeting of said committee was held in the office of the Director, Technical Education & Industrial Training, Punjab, sector 36-A, Chandigarh on 30.03.2022 at 3.00 P.M. The committee decided on the above agenda item as follow:--

"In this regard, it was decided by the committee that as the new bye-laws of Shaheed Bhagat Singh State University, Ferozepur is yet to be framed, bye-laws of erstwhile SBSCET, Ferozepur may be adopted (except retirement age) on regular, contractual employees of SBSSU, Ferozepur till new bye-laws is framed for the later. Since the university is receiving some grants from state of Punjab therefore wherever the bye-laws are silent, Punjab Civil Service rules will be applicable. As far as retirement age is concerned, clarification needs to be sought from the Department of Finance Chandigarh through Technical Education department."

The complete case was sent to Department of Finance Chandigarh

through Technical Education Department vide Institute letter no. SBS/Fzr/Estb/E-1/596-599 dated11.05.2022 (Annexure-IV, Page No.74-76) and ratification of above minutes of meeting dated 30-03-2022 is being put up in this BOG meeting vide agenda item no.03.03.

Item No.1.6 Charge of Officiating Registrar, Shaheed Bhagat Singh State University, Ferozepur

Decision:

While discussing the action taken report it was informed by the Hon'ble Vice-Chancellor that the charge of officiating Registrar has been given to Dr. Arun Kumar Asati as Sh. Jatinder Kumar Aggarwal and Dr. Raminder Pal Singh have shown inability to continue the additional responsibility of the officiating Registrar due to health-related problems.

Action:

As per the above decision Dr. Arun Kumar Asati, Professor (ME)was given the additional responsibility of the post of Registrar in place of Dr. Raminder Pal Singh (Professor Deptt. of Applied Sc. & Humanities) vide office order no.3772-77 dated 21.10.2021 (Annexure-V, Page No.77).

Further, Dr. Arun Kumar Asati has shown inability to continue the additional responsibility of the officiating Registrar due to health-related problems. The 3rd & 4th meeting of Finance Committee of Shaheed Bhagat Singh State University, Ferozepur was held on 22-06-2022 & 19-09-2022 under the Chairmanship of Hon'ble Vice Chancellor, Shaheed Bhagat Singh State University, Ferozepur.

During, 4th FC Meeting, it was informed to members that Travelling Allowance has been approved by BOG and FC, but still it is to be implemented as representative of FD, Sh. Jatinder Kumar and representative of DTE/IT Sh. Mohanbir Singh Sidhu, has pointed out that TA shall be as approved by Punjab Government. It was also pointed out that University has its own Finance Committee and BOG and has right to approve rates at par with other Universities. Therefore, in view of earlier approval of the BOG, it was decided that the issue will be discussed in next BOG meeting.

Item No.03.06 Ratification of Extra Ordinary Leave (EOL)

The following faculty of the institute were granted Extra Ordinary Leave (EOL) as per detail given below:

- 1) Dr. Rakesh Kumar, Associate Professor (Mechanical Engg.) was granted Extra Ordinary Leave (EOL) for two years w.e.f 07.08.2018to 06.08.2020 to join as Associate Professor at NIT, Jalandhar without any service benefits (increment, pension etc.) (Annexure-XVIII, Page No.115).

Item No.03.07 Ratification of withdrawal of Charge of Director

As per the directions of Hon'ble Principal Secretary, Department of Technical Education & Industrial Training, Punjab, Chandigarh, the charge of Director headed by Dr. T. S. Sidhu was withdrawn vide order dated 20.01.2022 (Annexure-XXII, Page No.119-121) as there is no post of Director in the University as per University Act 10 of 2021 (Annexure-XXIII, Page No.122-139). Further all Administrative action will be done through Registrar of the University.

Accordingly, an office order regarding relieving of charge of Director was issued vide office order no. SBSSU/Fzr/E-1/5001-08 dated 20.01.2022 (Annexure-XXIV, Page No.140).

Item No.3.08 Complaints received regarding alleged irregularities in SBS State University, Ferozepur

A letter was received from the Office of PSTE/IT, Chandigarh vide letter no. PA/PSTE&IT/2280 dated 21.07.2022 regarding meeting to be held on 2nd August, 2022 to review the proceedings against 29 complaints received regarding alleged irregularities in this institute. Accordingly, a meeting was held by committee headed by PSTE&IT with other members such as DTE/IT, DCFA, ACFA and Registrar of the University on 2nd August, 2022. The status report against 29 complaints in this regard was submitted during this meeting. Later, a review meeting was held on 19th Jan, 2023 by ACS TE/IT (vide memo no 21 dated 18.01.23).

Now, the University has received letter from the office of DTE/IT, Pb, Chd vide ref. memo no. 31 dated 24.01.2023, regarding decisions taken during meeting with Ex. PSTE on 2nd August, 2022 and approved by Hon'ble Chief Minister (as Chairman BOG). The above letter is annexed at Annexure No.XXV, Page No.141-144.

According to this letter various recoveries are to be done from many employees and the recovery amount is huge in some cases. So, appropriate decision is to be taken regarding schedule and instalments of recovery. As per para no 07, services of two employees (one Regular and other on purely adhoc basis) is recommended for termination due to overage selection. Also, as per Para No 1, an able advocate be hired to defend case of promotion in a better way. Punjab Govt. guidelines regarding recovery of excess payment made by employer in view of judgement of Hon'ble Supreme Court of India in case of State of Punjab V/s Rafiq Masih (white washer) and others is placed at Annexure-CX, Page No.435-436. The proposed action plan for implementation of the decisions approved by Hon'ble Chief Minister (as Chairman BoG) is put before Board for appropriate decision.

Extension of contract period of Sh. Parvesh Puri, Clerk, reliving of Sh. Mukesh Sachdeva, Helper Health Club, Extension of contract period of Mrs. Shaminder Kaur, Clerk and relieving of Mr. Dinesh Kumar, Clerk & relieving of Mrs. Harjinder Kaur Bajwa, Staff Nurse (Female)

The complete case was put up in the 1st meeting of BOG of this University vide agenda item no. 1.17 (ii, iii & iv) (Annexure- XXXVII, Page No.175-179), the decision in the 1st Meeting BOG, SBSSU, Ferozepur dated 25.06.2021 (Annexure- XXXVIII, Page No.180-186), a five member committee was constituted to look into the decision. The meeting of said committee was held in the office of the Director, Technical Education & Industrial Training, Punjab, Sector-36-A, Chandigarh on 30.03.2022 at 3.00 P.M. the committee decided on the above agenda items as given below: -

- "1) It is recommended that services of Mr. Parvesh Kumar, Clerk be extended on earlier terms and conditions from date of end of his contract on 02-01-2020 till the decision in the next meeting of BOG or appointment of regular staff. HOD/Incharge should verify the attendance and his salary be processed by the institute.
- 2) The post of Instructor cum caretaker Health Club was advertised in 3 newspapers in 2012. None of the applicant was found suitable. One of the applicant Mr. Mukesh Sachdeva was appointed as Helper Health Club on recommendation of staff selection committee, SBSSTC, Ferozepur and approval of BOG in 10th meeting for one year on 01-01-2013. His contract was extended every year till expiry on 02.01.2020. It has been found now by the committee that Helper Health Club is not a sanctioned Post in the Institute.

So, it is recommended that services of Mr. Mukesh Sachdeva, be extended on earlier terms and conditions from date of end of his contract on 02-01-2020 till last date of the one-month notice, which shall be served after receiving of minutes of meeting held on 30.03.2022 in the SBSSU,

Ferozepur. HOD / Incharge should verify the attendance and his salary be processed by the institute till last date of working in this University. His contract be terminated from the next day of last date of the one-month notice, which shall be served after receiving of minutes of meeting at SBSSU, Ferozepur.

- 3) It is recommended that services of Mrs. Shaminder Kaur, Clerk (Poly wing) be extended on earlier terms and conditions from date of end of her contract on 31-10-2019 till the decision in the next meeting of BOG or appointment of regular staff. HOD / Incharge should verify the attendance and her salary be processed by the institute.

As per the recommendation vide minutes of meeting dated 30.03.2022 & approval dated 26.04.2022 of the competent authority the services of Mr. Parvesh Kumar, Clerk was extended on earlier terms and conditions from the date of end of his contract i.e. from 02.01.2020 till the decision in the next meeting of BOG or appointment of regular staff vide officer order no.370-74 dated 29-04-2022 (Annexure-XXXIX, Page No.187). Now, Mr. Parvesh Kumar, Clerk has requested vide his request dated 13.05.2022 (Annexure-XL, Page No.188) for extention of his contract

- & regularization of his services. So, the matter is placed before the BOG for approval/ratification of term extended of Mr. Parvesh Kumar, Clerk w.e.f. 02.01.2020 to till the decision of BOG.
- 2) As per the recommendation vide minutes of meeting dated 30.03.2022 & approval dated 26.04.2022 of the competent authority the services of Mr. Mukesh Sachdeva, Helper Health Club was extended on earlier terms and conditions from the date of end of his contract i.e. from 02-01-2020 till last date of the one month notice vide office order no.331-335 dated 26.04.2022, his contract in this Institute was terminated w.e.f. 27.05.2022 (Annexure-XLI, Page No.189).

The matter is placed before the BOG for ex-post facto approval and ratification please.

- 3) As per the recommendation vide minutes of meeting dated 30.03.2022 & approval dated 26.04.2022 of the competent authority the services of Mrs. Shaminder Kaur, Clerk (Poly Wing) was extended vide office order no.387-91 dated 29.04.2022 (Annexure-XLII, Page No.190) on earlier terms and conditions from date of end her contract on 31.10.2019 till the decision in the next meeting of BOG or appointment of regular staff.
 - Mrs. Shaminder Kaur, Clerk has requested vide her request dated 18.05.2022 (Annexure-XLIII, Page No.191) for extention of his contract & regularization of her services. So, the matter is placed before the BOG for approval/ratification of term extended of Mrs. Shaminder Kaur, Clerk w.e.f. 31.10.2019 to till the decision of BOG.
- 4) As per the recommendation vide minutes of meeting dated 30.03.2022 the services of Mr. Dinesh Kumar, Clerk was extended vide office order no. 392-95 dated 29.04.2022 (Annexure-XLIV, Page No.192) on earlier terms and conditions from date of end of his contract on 31-10-2019 till his movement on leave applied without pay w.e.f. 14-10-2021 and his contract was cancelled w.e.f. 14.10.2021. The matter is placed

- before the BoG for ex-post facto approval of term extended of Mr. Dinesh Kumar, Clerk w.e.f. 31.10.2019 to 4.10.2021. The Board may ratify his extension and his contract was canceled w.e.f. 14.10.2021.
- 5) As per the recommendation vide minutes of meeting dated 30.03.2022 the services of Mrs. Harjinder Kaur Bajwa, Staff Nurse (Female) was extended vide Office Order No. 396-400 dated 29.04.2022 (Annexure-XLV, Page No.193) on earlier terms and conditions from the date of end of her contract on 31-07-2021 till her movement on leave applied without pay w.e.f. 06.12.2021 and her contract was cancelled w.e.f. 06.12.2021. The matter is placed before the BOG for ex-post facto approval of term extended of Mrs. Harjinder Kaur Bajwa, Staff Nurse (Female) w.e.f. 31.07.2021 to 06.12.2021. The Board may ratify her extension & cancel her contract w.e.f. 06.12.2021. However, she has also resigned from the post of Staff Nurse (Female) w.e.f. 18.02.2022 (Annexure-XLVI, Page No.194).

The matter is placed before the Board for ratification/appropriate decision please.

Item No 03.10 Chances for applying through proper channel

As per Institute bye-law 26(26.2) the faculty/staff can apply through proper channel only 02 times in a calendar year. The bye-law rule 26.1 and 26.2 is reproduced below:

"26.1 No application shall be forwarded unless: - (a) The applicant has completed two years service in the College. (b) The Head of Department certifies that he can make alternative arrangements till the post is filled in on regular basis and that the arrangements will be without any detriment to work. (c) The Head of Department certifies that persons possessing the qualifications prescribed for the post will be available from the open market.

26.2 An employee who meets the requirements mentioned at 26.1 above can be allowed to submit two applications in the course of year."

In the last few years, the admission in various courses has reduced and the institute is undergoing rationalization process to optimize the use of faculty/staff. There are many departments in which the student's strength is very less and the faculty/staff may become surplus in near future. So, keeping in mind the financial position of the institute and future career of faculty/staff it is proposed to increase the number of chances for applying through proper channel in other institute/department.

The case is placed before the BOG for approval to increase chances 04 OR unlimited chances in place of 02 through proper channel in the calendar year.

Item No.03.11 Polytechnic Wing Continuation decision

As per approval by the BOG vide agenda item no. 8.13 (Annexure-XLVII, Page No.195-214), the Polytechnic Wing was started with the grant received from NABARD in 2009, the detail Project Report for running the Polytechnic Wing courses & posts were approved in the 19th meeting vide agenda item no. 19.13 (i) of Finance Committee(Annexure-XLVIII, Page No.215-218).

Now, this Institute (SBSSTC, Ferozepur) has been upgraded as Shaheed Bhagat Singh State University, Ferozepur vide Act no. 10 of 2021(Annexure-XXIII, Page No.122-139). As per this Act of Regulations (at Sr. No 19 (j) 'The Degrees, Diplomas, certificates and other academic distinctions to be awarded by the University, the qualifications for the same and the amounts to be taken relating to the granting and obtaining of the same'). The Diploma courses of this Polytechnic Wing are affiliated to Punjab State Board of Technical Education and Industrial Training, Punjab. So, there is proposal to shift the affiliation of Diploma Courses of Polytechnic Wing from PSBTE/IT, Punjab to SBS State University, Ferozepur. In case the Board does not agree on the above mentioned proposal, then closure of Polytechnic Wing from the upcoming Academic session i.e. 2022-23 may be considered. This is to mention here that at present there are 12 Lecturers working in Poly Wing on regular basis. Also, there are 313 students presently enrolled in Poly Wing. The decision may also be taken for adjustment of 12 regular faculty members. The representation received from Poly Wing faculty vide

As per minutes of meeting held on 12.04.2022 under the Chairmanship of Vice Chancellor, SBSSU, Ferozepur it was decided

to take up the matter of continuation of Poly Wing during the next BOG meeting (Annexure-L, Page No.220-221).

It is pertinent to mention that on 26-07-2022, Sh. Rajnish Dahiya, Hon'ble MLA (Rural) Ferozepur sent letter to Hon'ble Chairman SC/ST & BC welfare committee Punjab, Chandigarh regarding SC/ST students studing in various courses of Polytechnic wing of SBSSU, Ferozepur and steps should be taken not to close this Polytechnic wing. Complete information was sent to DTE/IT Chandigarh vide letter no 3415-16 dated 27-09-22 & letter no. 3621-23 dated 11-10-2022 (Annexure-LI, Page No.222-230). The letter was received from vide ref. no. DTE/IT, Pb. vide file no. TECH-ECC026(16)/5/2022-ENGINEERING COLLEGE CELL 1/441628/2022 dated 11-10-2022 (Annexure-LII, Page No.231) to put complete case in next BOG meeting.

The matter is put up before the BOG for appropriate decision please.

Item No.03.12

Approval for withdrawal of conditions of pending inquiry and to release retirement benefits to Dr. Manoj Kumar Kushwaha, Associate Professor (ME)

The institute has received a letter from AICTE, New Delhi alongwith CBI report (Annexure-LIII, Page No.232-249). The AICTE has mentioned that CBI has recommended RDA for Major Penalty against Dr. Manoj Kumar Kushwaha, Associate Professor (Mechanical Engg.) for preparing inspection report of Shri Sai Polytechnic, Durg, without visiting the institute and giving a favourable report to the institute which had no building and requested to take action as per recommendations of CBI report and inform AICTE, accordingly.

The complete case was put up in the 36th meeting of BOG vide agenda item no. 36.04 (Annexure-LIV, Page No.250-251), the board has decided that departmental action against Dr. Manoj Kumar Kushwaha as per the recommendation of CBI for departmental action under major penalty should be taken at Govt. level as he was earlier suspended and subsequently reinstated at the level of Government."

As per the above decision a letter was sent to Hon'ble Director Technical Education & Industrial Training, Pb., Chandigarh vide letter no. 7885-86 dated 19.01.2021 (Annexure-LV, Page No.252).

Now, Director, Technical Education & Industrial Training, Punjab, Chandigarh vide Endt. No. 336/S-2/ECC/2021 dated 18.08.2021(Annexure-LVI, Page No.253-254), the following orders have been received: -

"it is humbly submitted that in my retirement order notified by the letter under reference it is specifically mentioned, "The superannuation of Dr. M.K. Kushwaha, Asso. Professor is subject to the pending CBI inquiry against him.". This embargo is unwanted, undesired and against the rules.

It is intimated that merely on the ground that an inquiry is pending against any officer his superannuation benefits can not be withhold. The matter, referring which, embargo has been put in my retirement orders is more than four years ago and I have retired from the service on 28.02.2021. In this connection it may be added for your information that a pending departmental inquiry necessarily means inquiry which has started. The inquiry usually starts with the issuance of the charge sheet.... unless a charge sheet has been issued it can not be accepted that a departmental inquiry is pending against the petitioner. R.P.Sharma vs Union of India and others, 1984 (2) S.L.R. 323 (M.P):1984 (1) SLJ 277. Attention is also invited to proviso 3 (a) below rule 2.2 (b) of Punjab Civil Services Rules, Volume II, which provides, "(a) a departmental proceeding shall be deemed to be instituted on the date on which the statement of charges is issued to the Officer.....". Till date neither charge sheet has been issued nor a statement of charges is served upon me. Therefore, like other officers, I retired from the service unbolted and unblemished.

Kindly peruse the provision of Rule 2.2 of Punjab Civil Service Rules, Volume II, which provides, " (2) Such departmental proceedings, if not instituted while the officer was in service whether before his retirement or during his reemployment; (i) shall not be instituted save with the sanction of the Government; (ii) shall not be in respect of event which took place more than four years before institution." It is implied that the government is within its power to initiate departmental proceeding against any retired officer only in cases where the event took place within four years. In my case no such departmental proceedings can be initiated at this stage.

Sir, in view of the position explained above, it is humbly prayed that the embargo/rider made on my retirement orders may kindly be withdrawn and all pending retrial benefits be released to me."

From the above, it reveals that Dr. M.K. Kushwaha, Associate Professor (Mechanical Engg) was suspended on 07.05.2012 and was reinstated on 05.04.2013 with the condition of pending enquiry. But till date no charge sheet has been issued to him.

Further he has been retired w.e.f. 26.02.2021(Annexure-LVIII, Page No.259). The event of his suspension took place 9 years before his retirement.

As per provision (3) below rule 2.2 (b) of Punjab CSR Vol-II:"No Such judicial proceedings, if not instituted while the officer
was in service, whether before his retirement or during his reemployment shall be instituted in respect of a cause of action
which arose or an event took place more than four years before
such institution"

So, keeping in view provision (3) below rule 2.2 (b) of Punjab CSR Vol-II and request dated 20.08.2021 of Dr. M.K. Kushwaha, the condition of pending CBI inquiry imposed in his retirement orders No. 8330-39 dated 26.02.2021 may be withdrawn and all his pending retirement benefits be released to him.

The complete case is put up before the BOG for appropriate decision please.

Item No.03.13 Regarding revision of panel of advocate to defend/present cases in Hon'ble Punjab & Haryana High Court& to increase their legal fees

As per record a agenda item regarding revision of Panel of advocates put in the 9th meeting of BOG vide agenda item no.9.26 (Annexure-LIX, Page no.260-263). The panel of advocates for defending the cases was approved vide agenda item no. 19.13 of Finance Committee (at Annexure-LX, Page No.264-267). One of our panelist advocate Sh. J.S. Ahluwalia expired two years ago and there is a need to replace an advocate in his place. Another Advocate Sh. Ramandeep Singh Pandher joined as Senior Deputy Advocate General, Punjab and hence left the Panel (Annexure-LXI, Page No.268).

Therefore, the University want to revise the panel of advocates for Hon'ble District Courts, Hon'ble Punjab & Haryana High Courts and Hon'ble Supreme Courts.

The advocates on the panel of Institute often refuse to give their consent to defend the court cases. Keeping in view the amount being paid by the Institute which is 15500/- for Hon'ble Punjab & Haryana High Court, Rs. 10500/- for Hon'ble State Consumer Court, Rs.5500/- for Hon'ble District Court/District Consumer Court & Rs.2000/- for Legal Notice, it is proposed to increase their legal fees to a justifiable limit.

The complete case is put up before the BOG for appropriate decision please.

Item No.03.14 Regarding implementation of Child Care Leave policy as per Punjab Govt. instructions

Mrs. Daljeet Kaur, Associate Professor (CSE) & others have requested vide diary no. 398 dated 26.04.2022 (Annexure-LXIII, Page No.295-296), the female employees of the University denied the child care leave whenever applied. The reason cited is the mention of some past BOG meeting decision.

As per record regarding availing Child Care Leave- the case of Smt. Rajni Sharma, Senior Assistant was put up in the 20th meeting of BOG vide agenda item no. 20.31 (v) (Annexure-LXIV, Page No.297-299), the BOG was decided that "after through discussion, it was decided not to implement the notification of Child care leave of Punjab Govt. in the Institute."

The college bye-laws are silent regarding child care leave. The Punjab Govt. has issued letter no. 6/26/2011-6P.P.3/2046 dated 22.12.2011 with the following highlights (Annexure-LXV, Page No.300-302).

- (i) Those Govt. female employees whose children are under age of 18 can take one year (365 days) child care leave throughout service.
- (ii) This leave will be admissible to look after the two surviving children and for their examination or illness. For this documentary proof must be submitted.
- (iii) During this leave salary will be admissible as incase of earned leave and prior approval of the leave will be required from the competent authority.
- (iv) Such leave may be granted in more than one spells, but it shall not be granted in more than three spells in a calendar year.
- (v) However, it shall not be granted for a period of less than fifteen days.

Accordingly, the matter is put up before the BOG for appropriate decision for approval of implementation of Child Care Leave policy

 3^{rd} Meeting of Board of Governors held on 17.02.2023 in this University as per Punjab Govt. instructions dated 22.12.2011.

Writing-off non working Computers and other electronic items

Store Section has sent a note dated 25.10.2021 along with committee recommendation to write-off non working computer systems and other electronic items of different departments (Annexure-LXVI, Page No.303-327). As per this note the purchase value of these items is above Rs. 5 Lacs and therefore approval is required from BOG as per the college purchase rules.

As per the letter received from the Govt. of Punjab, Department of Technical Education & Industrial Training, Punjab, Chandigarh vide Memo No. 9/11/06-5TE2/560 dated Chandigarh 29-2-2008 the above said items may be written-off based on the lifetime of the equipments.

However, the disposal-off these items from the Central Store could be done through vendors shortlisted by the Deptt. of Information & Technology Punjab (Annexure-LXVII, Page No.328).

As our past experience, Deptt of Information& Technology does not respond to our correspondence for giving the names of the approved vendors. However, the task of writing off the obsolete electronic items was done with the approval of the BOG in its 8th meeting vide agenda item No. 8.15(iii) (Annexure-LXVIII, Page No.329-331).

Now it is proposed to dispose off the above said electronic items either through the vendors approved by the Deptt of Information & Technology, Punjab or through the open auction by advertising in local news papers and only those vendorsshall be considered eligible who have authorization

Since inception Training and Placement Cell of this Campus is looking after Campus Placements, internships, workshops, seminars, State Level Mega Job Fairs and other activities as per the directions of DTE/District Administration /District Bureau of Employment Generation.

Newly, proposed Career Development Centre (CDC) at SBSSU, Ferozepur will cater to following additional responsibilities in addition to routine affairs as mentioned above:

- To reach out actively to corporate world for facilitating best placements for students.
- To provide logistics support visiting companies at every stage of placement process.
- To act as interface between the industry and the students, and enable students to select their career options.
- To organize career related seminars / workshops to enable the students to become successful professionals.
- To help students to improve their skill level by organizing various short term skill development courses.
- To improve communication skills of students by organizing Foundation Courses on proficiency in English speaking to help them cope up with today's challenging scenario.
- To organize Skill Development Programmes to help bridge the gap between requirements of Corporate world and Students present skill level.

- To propose necessary changes in the curriculum / study scheme as per the requirements of
- To organize Talent / Aptitude / Quiz / Verbal / Non-Verbal Reasoning Tests to help them prepare for Recruitment Process.
- To organize Group Discussions for students to improve their speaking and conversation skills.
- To motivate students towards self employment by covering activities related to E-Cell, National Innovative & Start-up policy (NISP) and Incubation Center.
- To build Alumni Cell within the purview to have strong Alumni Networks.

Madhav Gopal, Pharmacist has requested vide his letter diary no. 236 dated 18.04.2022(Annexure-LXX, Page No.339) for the change of his designation from Pharmacist to Pharmacy Officer as per the notification issued by the Govt. of Punjab, Department of Health and Welfare Endst. No.4/06/2014-3ff3/1522613/1-2, dated, Chandigarh 12-07-2019 (Annexure-LXXI, Page No.340), which is reproduced as under:-

Madhav Gopal, Pharmacist has already requested vide his letter no. 1590 dated 27.08.2019 (Annexure-LXXII, Page No.341) for the change of his designation from Pharmacist to Pharmacy Officer as per the notification issued by the Govt. of Punjab, Department of Health and Welfare Endst. No. 4/06/2014-3fh5/1522613/1-2, dated, Chandigarh and he has also enclosed the copy of Office order no. 2733 dated 14.08.2019 (Annexure-LXXIII, Page No. 342) of Beant College of Engineering and Technology vide which designation of Pharmacist has been re-designated as Pharmacy Officer without any financial benefits in their 18th BOG meeting vide agenda item no. 18.07.

The Complete case is put up before the BOG for approval to redesignate the designation of Pharmacist of this University as Pharmacy Officer without any financial benefits.

Submitted for approval please.

Item No. 03.18 Sanctioning of posts for the department of B. Sc (Agriculture) in line with ICAR

In the 33rd meeting of BOG vide agenda item no. 33.8 (Annexure-LXXIV, Page No.343), it has been approved to sanction 01 post of Professor, 02 posts of Associate Professor & 08 posts of Assistant Professor in the Department of B.Sc Agriculture.

Now, HoD - B. Sc Agriculture has requested vide his letter dated 07.06.2022 (Annexure-LXXV, Page No.344) that as per the website of the Department of Agriculture and Farmers Welfare, Punjab the Government has deferred the implementation of Section 23 of the Punjab State Council for Agricultural Education Act 2017 till 30.06.2022 (Annexure-LXXVI, Page No.345-349). So, there is need to comply with the norms fixed by the council within this extended period.

The HOD has requested to get the approval from Board of Governors of the University for the recruitment of the faculty and staff as per the norms prescribed by the council.

The matter is put up before BOG for consideration and appropriate decision please.

Item No. 03.19 Pay fixation of employees of SBS University, Ferozepur by the office of DTE/IT, Chandigarh for compliance of conditions to get Grant in Aid

The complete case was put up in the 2nd BOG vide agenda Item No. 02.06 (Annexure- LXXVII, Page No.350). The Board has directed for vetting of the remaining cases on priority basis, having follow-up with DTE/IT Punjab and put the item in next meeting of the BOG for approval, after completion of the vetting of pay fixation of all employees.

As per the above decision the Institute had sent a letter no.4665 dated 28.12.2021 & reminder SBS/Fzr/E-3/588 dated 10.05.2022, SBS/Fzr/Estb-1/732 dt 23.05.2022, SBS/Fzr/Estb-1/1211 dt 15.06.2022 & SBS/Fzr/Estb-1/1808 dt 19.07.2022 (Annexure-XIII, Page No.92-96), a letter was sent to Deputy Controller (Finance & Accounting), DTE/IT, Chandigarh vide letter no. 732 dated 23.05.2022 the list of employees whose pay has been vetted at DTE/IT level committee DCFA/ACFA is placed at Annexure-LXXVIII, Page No. 351-354.

Here it is worth mentioned that pay scale to teaching and non-teaching employees were given as per norms of AICTE and Punjab Govt., respectively. The office of DTE/IT had put the condition for getting vetting of pay fixation of all employees from the office of DTE/IT for getting Grant-in-Aid for the formation of University w.e.f. 1.04.2021 as these vetted pay fixation is required to be implemented w.e.f. 1.04.2021 for using the grant-in-aid. However, some employees have got stayed from Hon'ble Punjab and Haryana High Court against the implementation of these vetted orders.

Now DTE/IT, Chandigarh vide file no. TECH-

ECC042(14)/24/2021/Engineering College Cell/491460/2023 dated 16.01.2023 (placed at Annexure-XIV, Page No.97) has forwarded clarification of AICTE dated 04.10.2022 and has instructed to deal pending cases as per AICTE guidelines/instructions. It has also been conveyed that the employees who are being given 70% salary, such cases may be vetted from DCFA/ACFA of Head office.

The matter is placed for BOG for information please.

Item No.03.20 Regarding Superannuation Age

The Institute has received Punjab Govt. notification no. 22/2/2012-3FP2/237 dated 02.03.2020 through DTE/IT endorsement no. 279-283/S-6/ECC/2020 dated 19.03.2020 (Annexure-LXXIX, Page No.355-358) vide which the Govt. of Punjab, after careful consideration, has reviewed the existing Rule 3.26(a) of Punjab Civil Services Rule Volume-I, Part-I which reads as:

3.26. (a) Except as otherwise provided in this rule, the date of retirement of a Government employee shall be as follows, namely: – (i) fifty-eight years in the case of Group 'A', 'B' and 'C' employees; and (ii) sixty years in the case of Group 'D' employees;

Provided that if the State Government is of the opinion that it is necessary and expedient so to do in public interest, the Service of a Government employee or a class of Government employees, may be extended for a period of two years on yearly basis, subject, however, to giving an option within a period of three months before the date of retirement by the Government employee, who seeks extension: Provided further that a Government employee, who is already on extension, shall also give fresh option within a period of one month from the date of publication of these rules: Provided further that no Government employee, shall be retained in Service, after the completion of his extended period of Service. However, under exceptional circumstances, if the State Government considers it necessary and expedient so to do in public interest, it may extend the Service of a Government employee beyond the aforesaid limit, for the reasons to be recorded, in writing.

This rule which has further been amended as below:

- "3.26 (a) Except as otherwise provided in this rule, the date of retirement of Government employee shall be as follows: -
- (i) Fifty-eight years in the case of Group 'A', 'B' and 'C' employees;

and

(ii) sixty years in the case of Group 'D' employees.

...meticulous compliance of these instructions shall be ensured and any laxity or deviation from these instructions shall be viewed seriously.

This amendment were made to go away with the two-year extension given the employees.

The above decision of Punjab Government was endorsed to the institute by the DTE/IT vide letter No. 279-283/S-6/ECC/2020 dated 19.03.2020. The Institute had sought clarification from the office of DTE/IT vide no. 7147 dated 4.11.2020 by reproducing the by-laws No. 2.18 of institute as below:

"The age of retirement of both teaching and non-teaching employees of the institute shall be 60 years. The employees of the institute may be allowed to retire on the last day of the month irrespective of the actual date of their retirement as per Punjab govt. Rules". It was mentioned in this letter that as per above said clause No. 2.18, the retirement age of both teaching and non-teaching employees of the institute is 60 years and employees are being retired at the age of 60 years. The office of DTE/IT was asked for direction in this regard (Annexure-LXXX, Page No.359). Further, reminder No. 7516 dated 17.12.2020 and 7930 dated 22.01.2021 were sent to the office of DTE/IT for seeking guidance (Annexure-LXXXI, Page No. 360-361).

The office DTE/IT has informed to the institute vide file no. TECH-ECC042(14)/28/2020/ECC/1/139712/2021 dated 04.02.2021, that institute has to take action for retiring the employees as per the letter dated 19.03.2020 issued by DTE/IT (Annexure-LXXXII, Page No.362).

The office of DTE/IT vide file No. TECH-ECC-042(14)/28/2020/ECC/144903/2021 dated 16.02.2021 has further asked about what action the institute has taken on the letter of DTE/IT dated 19.03.2020 and further asked to give the name of employees who were not relieved as per the direction of DTE/IT latter dated 19.03.2020 (Annexure-LXXXIII, Page No.363-365).

Accordingly, some the employees who have attained the age of 58 years were superannuated by the institute as per detail given below: -

The employees at Sr. No. 01 to 05, 08 & 09 have filed CWPs in the Hon'ble Punjab & Haryana High Court, Chandigarh against these orders. The Hon'ble High Court granted stay against the reliving orders upto the next date that was 20.05.2022 and further date of hearing of these cases on 07.09.2022. In compliance to the orders of Hon'ble High Court Mr. Raj Kumar, Workshop Instructor & Smt. Indu Bala, Assistant Librarian has been allowed to rejoin their duties in this University. It is mentioned here that Dr. Lalit Sharma,

Professor Applied Sciences, sought information from DTE/IT, Chandigarh under RTI regarding Superannuation Age of employees of SBSSU, Ferozepur, in reply to this vide letter dated 05-04-2022, it was mentioned "ਹਵਾਲਾ ਅਧੀਨ ਪ੍ਰਤੀਬੇਨਤੀ ਰਾਂਹੀਂ ਮੰਗੀ ਸੂਚਨਾ ਸਬੰਧੀ ਦੱਸਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਰਿਕਾਰਡ ਵਿੱਚ ਅਜਿਹਾ ਕੋਈ ਪੱਤਰ ਉਪਲੱਬਧ ਨਹੀਂ ਹੈ". (Annexure-LXXXIV, Page No.366-367). The others employees (Mr. Manjit Singh - Lab. Supdtt., Dr. Lalit Sharma- Professor (DASH) & Mr. Prabhudyal Singh - Lab. Supdtt.) which were attainting the superannuation age of 58 years in this year have also obtained the stay orders from the Hon'ble Punjab & Haryana High Court. So, accordingly in compliance of stay orders of Hon'ble Court they have not been relieved from the services of this University.

It is also informed that other Universities i.e. MRSPTU, Bathinda & I.KG PTU, Jalandhar has not retired any employee at the age of 58 years. SBSSU, Gurdaspur & this university has retired employees at the age of 58 years. Now the SBSSU, Gurdaspur has also stoped retiring the employee at the age of 58 years.

It is pertinent to metion here that this University is currently facing financial crisis and it is not possible to recruit new staff.

Now keeping in view, the uniformity and financial position of this University, this University may be allowed not to retire the employees at the age of 58 years because as per College Bye-Laws 2.18 and on the pattern of other Univerties of Punjab State, the superannuation age of the employees of this University may be allowed at 60 years.

The complete case is placed before BOG for information please.

Item No. 03.21 Proposal for promotion from Supdtt Grade-II to Assistant Registrar

As per college bye laws 2.01: -

"All posts in the college shall normally be filled by direct recruitment by advertisement but the Board shall have the powers to decide that a particular post is filled by negotiations or by promotion form amongst the members of the staff of the college."

As per college bye laws 4.2: -

"The appointments by promotions shall be made on the basis of seniority cum merit as per procedure prescribed by the Punjab Government for its employees. The appointment by direct recruitment shall be made strictly on merit."

At present following Supdtt. Grade-II are working in this University:

It is informed that Sh. Rajesh Sethi was granted Earned leave along with Ex-India Leave w.e.f. 05-09-2022 to 02-12-2022 vide office order no.1889-93 dated 22-07-2022 & 1997 dated 27-07-2022 (Annexure-LXXXV, Page No.368-369). But after expiry of sanctioned leave (i.e. Ex-India Leave & Earned Leave) he has not joined his duty till date. Now Punjab Govt vide memo no. 31 dated 24.01.2023 (Placed at Annexure No.XXV, Page No.141-144) para 7.0 has ordered for termination of services due to overage appointment. Mr. Ganesh Chander, Supdtt. Grade-II is on deputation with PGIMER, Chandigarh upto 31.08.2024. As such at present Sh. Arun Chander is working as Supdtt. (Estb. Section) and Mr. Ashok

kumar is working as Supdtt. (Accounts Section) of this University.

For this Institution (now SBSSU, Fzr) 02 posts of Assistant Registrar are sanctioned. These both posts of Assistant Registrar are lying vacant for long time.

For promotion from Supdtt. Grade-II to Assistant Registrar qualification & eligibility are as under: -

"Graduate from a recognized University with the toal service of 5 years in administration as Superintendent Grade-II or equivalent post in the scale of Superintendent Grade-II"

Sh. Arun Chander is a graduate from Punjab University with total experience of more than 14 years as Supdtt. Grade-II and Sh. Ashok Kumar is B.Com / MBA with total experience of more than 08 years as Supdtt. Grade-II and as such these both employees fulfill the qualification/experience for promotion to the post of Assistant Registrar. As per record no complaint / enquiry is pending against them and their work & conduct is satisfactory.

It is pertinent to mention here that at present no regular Assistant Registrar/Deputy Registrar is appointed/working is this University. Temporary charge of Deputy Reigstrar (Estb) & Deputy Registar (Accounts) has been assigned as additional duty to the faculty members of this University. Due to teaching load & lack of administrative experience faculty members are requesting time and again for relieving them from additional responsibility as Deputy Registrar (Estb) & Deputy Registrar (Accounts).

At present this University is facing financial crisis and it is not possible to directly recruit Assistant Registrar & Deputy Registrar. If above said experienced internal Supdtt. Grade-II are promoted as Assistant Registrar then they will be eligible for grant of only 01/02 nominal increments and it will be more beneficial to strengthen administrative structure and to deal effectively the increased official

work load of this University.

However, Mr. Arun Chander, Supdtt. Grade-II & Mr. Ashok Kumar, Supdtt. Grade-II have submitted an undertaking that if there is any objection/instructions from any Hon'ble Court or Authority reagarding their promotion as Assistant Registrar and if they are accordingly reverted to the Post of Supdtt. Grade-II then they will not raise any objection and they will not approach any court of law. So, keeping in view the above situation and in the interest of University, it is proposed that Mr. Arun Chander, Supdtt. Grade-II (Estb. Section) & Mr. Ashok Kumar, Supdtt. Grade-II (Accounts Section) may be promoted as Assistant Registrar against the available vacant posts.

The matter is placed before the Board of Governors for consideration and approval please.

Item No. 03.22

Implementation of the recommendations of the 6th Pay Commission for the Non-Teaching & Teaching employees of Shaheed Bhagat Singh State University, Ferozepur

The Government of Punjab, Department of Finance (Finance Personnel-I Branch) vide Notification no. 09/01/2021-5FPI/671 dated 05-07-2021 has revised the pay scales of the employees w.e.f. 01.01.2016. As per Institute bye-laws 4.1, employees of the Institute are to be graded according to the grading proscribed by the Punjab Govt. for its employees and as per bye laws 2.16 the pay and allowances of all the employees of the society (Institute) shall be regulated in such a manner as may be decided by the Board from time to time. For implementation of revised pay scales for non-teaching employees of this University at par with those of the employees of the Punjab Government, approval of Board of Governors is necessary.

The detailed financial implications for the staff to be granted revised pay scales will be processed as per the fixation formula of the Punjab Govt. and routed through Finance Committee for the approval of the Board of Governors. The budget provision etc. will also be worked out and placed before the Finance Committee for the consideration and approval.

Accordingly, the matter was placed as Agenda Item No. 4.4 in the 4th meeting of Finance Committee of this University. The decision of this item is placed as under: -

Decision: -

The item was discussed and recommended. Further, the Finance Committee has advised for discussing it in the Board of Governors for final decision, in the light of facts of Punjab Govt. letter vide ref no FD-DPEDOADVC/15/2021-JD/3715-67 dated 08.07.2022 given by nominee of PSTE. (Annexure-LXXXVI, Page No.370).

As per the instructions of the Punjab Govt, the option of all non-teaching employees has been obtained. For this purpose, a committee has been constituted vide office order no. 5300 dated 09.02.2022 for pay fixation of the employees and after the approval of BOG, the orders of employees will be issued as per the options given by them.

The matter is placed before the BOG for consideration & approval to implement the revised pay scales w.e.f. 01.01.2016 for the non-teaching employees of this University as granted by the Punjab Govt. to its employees and to grant the revised allowances as announced by the Punjab Govt. from time to time.

Besides, the pay scales of teaching staff were also revised by the Central Govt./UGC w.e.f. 01.01.2016 and the Punjab Govt. is in the process of implementing it in the public HEIs. The same will be implemented in the University, as and when the notification is issued by the Punjab Govt. in this regard.

The matter is placed before the Board of Governors for consideration and approval, please.

Item No.03.23 Study leave/QIP leave regarding

In the 27th meeting of BOG vide agenda item No.27.3, the Board has decided to give study leave to only those faculty members who will do Ph.D from IITs. Further, it was decided that institute will not give any study allowance during the period of study leave.

However, in the 28th meeting of BOG vide agenda item No.28.8, the Board has decided to give 06 month additional study leave instead of total period of 03 years for conducting experiments at other institute, if the requests of Candidates are found to be genuine. But the candidates have to give an undertaking that they will complete the experiment work within 06 month time and submit the results to the institute thereafter.

- (1) An application dated 28.05.2018 of Mrs. Sonika Jindal, Assistant Professor- Computer Science department was received regarding 06 months study leave for Ph.D (experimental work). The permission for Ph. D (part-time) from IKGPTU, Jalandhar has already been given to concerned vide institute letter No.5771-72 dated 20.02.2018 and she has already availed 06 months study leave w.e.f 26.02.2018 to 12.07.2018 as per institute letter No.SBS/Fzr/5997-99 dated 23.02.2018 (Annexure-LXXXVII, Page No.371)

Sunil Behal, Assistant Professor-Applied Sciences department was forwarded to The Principal Coordinator QIP, IIT, Delhi for Ph.d Programme under QIP by institute vide letter No.SBS/Fzr/Estb./3022 dated 29.09.2017. Hence required certificates were issued to concerned from time to time. In this regard Sponsorship/No objection certificate was issued to concerned vide dated 14.06.2019 in which it was mentioned that the applicant has been relieved w.e.f 12.07.2019

full time for the programme on deputation (Annexure-LXXXVIII , Page No.372).

A letter No. MIMIT/PO/19/615 dated 27.06.2019 has been received from Malout Institute of Management & Information Technology, Malout which stated/decided that in future the cases of all the Govt. Promoted Engg. Colleges for granting Study leave would be approved by Hon'ble Technical Education Minister-cum-Chairman, BOG of the institute (Annexure-LXXXIX, Page No. 373).

Non-deduction of Licence Fee from Allottees of Govt.

As per bye-Laws No. 12.10 of Society, an allottee shall pay rent and water charges at the rates fixed by the Society from time to time which shall be deducted from the salary bill of the allottee. The Society of the Institute didn't fix the house rent /licensee fee to be charged from allottee.

In the 5th meeting of Finance Committee of the Society held on 15.5.1998 under the Chairmanship of Principal Secretary to Govt of Punjab, Department of Technical Education, in which representative of Secretary Finance was also present, it was decided vide agenda item No. 5.9 to charge only water and sewerage charges from the allottee w.e.f. 1.6.1998 (Minutes of 5th meeting of Finance committee are placed as **Annexure-C**, **Page No. 392-394**. No decision was taken to charge House rent (License Fee) from the allottee.

In the 20th meeting of BOG vide agenda item No. 20.27, it was decided by the Board to put up an agenda item in the next meeting of BOG for charging 5% License fee (Minutes of 20th meeting are placed as Annexure-CI, Page No. 395-399. Accordingly, an

agenda item No. 21.3 was put up in the 21st meeting of BOG for charging of 5% License fee from allottee. However, in this meeting of BOG, the Board had decided to charge the licensee fee as per policy of Punjab Govt. (Minutes of 21st Meeting of BOG are placed as Annexure-CII, Page No.400-402. But, the office staff didn't implement the decision on the plea that this decision was not specific. Therefore, it was reported in the agenda item No. 22.2 of 22nd meeting of BOG that this decision could not be implemented as this decision was not specific, therefore, this item will be put up again in the next meeting of BOG.

A committee was constituted of the following to examine the case of license fee to be charged from allottee.

- a. Finance Officer
- b. Deputy Registrar Accounts
- c. Deputy Registrar Establishment

The committee has reported that

"As per available information Punjab Govt Employees working in border districts such as Ferozepur and Gurdaspur, in Education Department, in Punjab State Electricity Board etc are getting Border Area Allowance @ 5% of Basic pay. Our Institute is also situated in the border area. So as per above all the employees of this institute are entitled for Border Area Allowance @5% of basic pay which is adjusted against the licensee fee payable by the employees residing inside the campus. The BCET Gurdaspur is also paying Border Area Allowance @5% of Basic pay.

During the Audit of the Institute for the period 2016-2021 by the AG Punjab, Chandigarh, the audit party raised the audit observation vide their memo no. #16 (OBS-155433) dated 24-09-2021 regarding non deduction of Licence fee from allotees of Government employees, the reply of which was submitted by the Institute (Annexure-CIII, Page No.403-409).

After that audit para was issued by the senior audit officer, Indian

Audit and Accounts department, Chandigarh in which they have mentioned that the department allotted accommodation to their employess in the campus of University and had not charged licence fee amounting to Rs. 95,29425/- during the period April-2016 to March-2021. The non charging of licence fee resulting loss to the institute. The reply of audit para was submitted by this institute (Annexure-CIV, Page No.410-414)

After that audit team visited this Institution on dated 20.10.2022 and issued memo no. AMG-IV/licence fee/ 2022-23/SPL-2 dated 20-10-2022 (Annexure-CV, Page No.415-418). After that this institute implemented the decision of the above said audit memo and issued vide office order no. SBSSU/ Accounts/A-4/ 3800 dated 21.10.2022 regarding deduction of licence fee w.e.f. 01.07.2022 (Annexure-CVI, Page No. 419) and submitted the reply to the senior audit officer vide office letter no. SBSSU/account/A-4/3805 dated 21.10.2022.

A letter DO no AMG-IV/DPcell/SR-16/TDP-2/AR-21-22/22-23/111 dated 13.12.2022 was received through Sr. Deputy Accountant General, Chandigarh (Annexure-CVII, Page No.420-426). The reply of DO letter again submitted by this Institution vide this office letter no. SBSSU/FZR/5016 dated 05.01.2023 (Annexure-CVIII, Page No.427-428).

AG Audit has directed to recover licence fee from 04/2016 to 06/2022. This University has started deduction of licence fee w.e.f. 01.07.2022. Now it is to be decided by Board regarding recovery of licence fee from 04/2016 to 06/2022.

The matter is put up before BOG for consideration and appropriate decision please.

Item No. 03.27 Pending recoveries as per A.G. Audit (Punjab)

As per Govt. of Punjab Act No. 10 of 2021 dated 01-04-2021, the Shaheed Bhagat Singh State Technical Campus, Ferozepur was upgraded to Shaheed Bhagat Singh State University, Ferozepur. Afterwards, this University started receving Grant-In-Aid (Since FY 21-22) for salary purpose from Punjab Government, A.G. Audit (Punjab) audited the accounts for last five years, i.e. from 2016 to 2021 and now annually audits and inspects the accounts of this University. Based on past Audit & inspection report of A.G. Audit (Punjab) various recoveries are to be done. The replies against all paras have been sent to AG Audit (Punjab). Punjab Govt. guidelines regarding recovery of excess payment made by employees in view of judgement of Hon'ble Supreme Court of India in case of State of Punjab V/s Rafiq Masih (white washer) and others is placed at Annexure-CIX, Page No.429-430.

The complete detail of pending recoveries to be done from employees by this institute is placed at Annexure- CX, Page No.431-436 for appropriate decision by BoG in this regard.

Item No. 03.28 Starting of School of Business and Commerce Studies in SBSSU-Regarding.

A meeting of Registrar, FO, COE, all Deans and HODs and was held on 16.01.2023 (Annexrue- CXI, Page No.437-438) regarding start of new courses in the university and some other issues. The meeting was chaired by Honourable Vice-Chancellor.

In this regard keeping in view the prevailing admission scenario, and future projections, it was decided to start the **School of Business and Commerce Studies** in SBSSU Ferozepur with immediate effect that will look after the various courses like B.Com, M.Com, BBA and MBA etc.

- 2) Associate Professor: 01
- 3) Assistant Professor: 02

It is worth mentioning here that these posts shall not be filled at present and the school of Business and Commerce Studies shall be run with existing available faculty in the SBSSU Ferozepur along with guest faculty on Lecture basis (if required).

2) Request received from Dr. Yogita Sharma, Assistant Professor (ME) working on consolidated salary 15000/-pm and others dated 27.05.2022 from for enhancement of consolidated salary from Rs.15000/- to Rs. 35000/- (for Ph. D) and 30000/- PM (for Non Ph.D) recommended by MLA Ferozepur Rural & MLA Ferozepur Urban

Reporting:

In this connection, it is informed that as per the requirement of the Departments these candidates were appointed on purely a temporary stop gap basis for the post of Assistant Professor in various departments on consolidated salary 15000/- pm. They have filed CWP No. 11230/2021 in the Hon'ble Punjab & Haryana High Court, Chandigarh against their reliving from University and got stay from Hon'ble High Court. However, in the 28th meeting of BOG vide agenda item No.28.8, the Board has decided to give 06 months additional study leave instead of total period of 03 years for conducting experiments at other institute, if the requests of Candidates are found to be genuine. However, the candidates have to give an undertaking that they will complete the experiment work within 06 month time and submit the results to the institute thereafter.
