# Item No.19.1 Confirmation of the minutes of the 18<sup>th</sup> meeting of Building and Works Committee.

The approved Minutes of the 18<sup>th</sup> meeting of Building and Works Committee were circulated vide letter no.SBS/Fzr/5101-06 dated 09/09/2014 to all members for their information and comments, if any (**Annexure-I, page-18**)

No comments have been received from any of the members. The approved Minutes (Annexure-I, pages 19-21) are put up before the  $19^{th}$  Building and Works Committee for confirmation please.

- Item No. 19.2: Action taken report on the agenda points of 18<sup>th</sup> meeting of B & WC
- Item: 18.1 Confirmation of the Minutes of the 18<sup>th</sup> meeting of B&WC
- Decision:The proceedings of 18th Meeting of Building and Works<br/>Committee were confirmed.Action:No action is required.
- Item: 18.2 Action taken report on the agenda points of 18<sup>th</sup> Meeting of B &WC
- Decision:The action taken report was approved.Action:No action is required.

## Item: 18.3 To approve the construction of Central library, Computer centre and Skill Development Centre.

- **Decision:** The administrative approval was accorded for the construction of Central Library, Computer Centre and Skill Development Centre with an estimated cost of Rs.471.23 lacs. Further, it was decided to release 25% payment of the estimated cost to PWD (B & R) as the first instalment for mobilising the resources.
- Action: The institute has conveyed to the PWD ( B & R) vide letter No SBS/Fzr/5211-18 dated 18-9-2014 (Annexure-II, pages 22) regarding the administrative approval for construction of Central Library, Computer Centre and Skill Development Centre with an estimated cost of Rs.471.23 Lacs and also requested to take up the matter for construction of the said building on priority basis. Institute has received a letter vide diary No SBS/Fzr/3256 dated 7/11/2014 (Annexure-II, pages-23-24) from PWD (B & R), Provincial Division, Ferozepur stating that the rough cost estimate of Rs.471.23 Lacs based on the Architectural Drawings of Architect department has been revised with detailed estimate of Rs.630.41 Lacs including civil, Public Health and Electrical works and sent to Technical Advisior to Hon, ble Chief Minister of Punjab through Chief Engineer, Patiala for getting it vetted..

# Item:18.4 To approve the Construction of Gymnasium Hall and Swimming pool.

**Decision:** The item was approved as proposed.

Action : Institute has written to GZSPTU Bathinda for preparing the architecture drawings. They have submitted the Architectural drawings and demanded consultancy charges. During the visit of Planning, Execution and Inspection Committee on 01.12.2014 at the institute, the architectural drawings received from the Architectural Department of GZS PTU Bathinda were presented to the Mr Tarun Garg , Sr . Architect (North) Patiala along with other members of the committee including PWD officials who were not very receptive to the proposed architectural drawings supplied by GZS PTU Bathinda and decided to review the drawings by asking fresh Architectural Drawings from Architecture Department, Patiala. The copy of Minutes of Meeting of Inspection Committee dated 01.12.2014 is placed at Annexure- III pages 25-26.

- Item 18.5: Approval to release the Full and Final Payment of Girls Hostel
- **Decision:** The item was approved as proposed. Further, it was decided that security amount shall be kept by the PWD (B & R) as per the terms and conditions of agreement between PWD (B & R) and the contractor. However, before releasing the security amount to the contractor, PWD (B & R) will be required to get satisfactory report from institute (SBSSTC).
- Action Taken : The institute has released the Full and Final Payment to PWD (B & R) as per the following details:

It is hereby worth mentioned that as per approval of Hon,ble Chairman BOG dated 04/02/2014 and letter Ref. SBSCET/FZR/2476-80 dated11/04/2014 written to PWD(B&R), Ferozepur regarding 'Deduction of Electricity Charges, an amount of Rs.13, 42,987/- has been deducted from Full & Final Payment on account of Electricity consumed by the contractor M/S G N Constructions, Amritsar during construction of New Girls Hostel and New Lecture Hall

Blocks in the campus. A copy of approval of Hon'ble Chairman BOG dated 04/02/2014 ( **Annexure-IV**, **pages 27-28** ) and letter Ref. No SBSCET/FZR/2476-80 dated 11/04/2014 written to PWD (B & R) Ferozepur for recovery of the said amount are placed at **Annexure-IV**, **pages 27-28 & Annexure –IV**,**pages-29**.

Accordingly after deducting the payment of Electricity charges amounting to Rs.13,42,987/-, the balance payment of Rs.36,00,460/- (49.43447-13.42987=Rs36,00,460/-) has been released to PWD (B & R), Ferozepur as Full and Final Payment for the construction of Girls Hostel (Mata Gujri Bhawan) in the campus vide letter ref. no sbs/fzr/5351-55 dated 26-9-2014.( **Annexure-IV, Pages-30-31**.)

# Item 18.5: Approval to release the Full and Final Payment of Lecture Halls and Tutorials.

**Decision:** The item was approved as proposed. Further, it was decided that security amount shall be kept by the PWD (B & R) as per the terms and conditions of agreement between PWD (B & R) and the contractor. However, before releasing the security amount to the contractor, PWD (B & R) will get satisfactory report from the institute (SBSSTC).

# Item19.3:Progress of New Boys Hostel being constructed under<br/>SC/ST Grants Scheme of AICTE, New Delhi and release of<br/>partial payment.

As approved in the 13<sup>th</sup> Building works Committee (vide agenda item no 13.4) and subsequent approval in the 14<sup>th</sup> meeting of Board of Governors (vide agenda item no 14.20), the construction work of Boys Hostel under SC/ST Grants Scheme of AICTE, New Delhi was allotted to PWD (B & R), Punjab (Ground +Ist Floor) for Rs.384.84 Lacs and subsequently an amount of Rs.1.0 crore was released to PWD (B & R) as the "Mobilization Funds". As per Agenda item No 15.4 of BWC, it was decided to pay 25 % advance to the executing Agency after every three months subject to the satisfactory report of the inspection committee.

A meeting of Planning , Execution and Inspection Committee was held on dated 24/07/2014 at SBSSTC, Ferozepur and recommended to release an amount of Rs.1.0 Crore to PWD (B&R) against the utilization certificate of Rs.100 Lacs submitted by PWD(B&R), but the payment was withheld due to some deficiencies pointed out by the committee. After rectification of these deficiencies, the same was recommended for release in the inspection held on 21/08/2014.

The Planning, Execution and Inspection Committee again inspected the building on 20.10.2014 and has pointed out some deficiencies in the building. Accordingly letter Ref. No:SBSSTC/FZR/5751-55 dated 22-10-2014 was written to Executive Engineer ,PWD (B&R) for rectification of these deficiencies (Annexure-VI, pages 46-47).

In the Meeting of Planning, Execution and Inspection Committee held in the institute on 01.12.2014, the committee has recommended to release a payment of Rs.1.25 Crore to PWD (B& R) keeping in view the rectification of all the deficiencies pointed out in the last inspection dated 20.10.2014 and progress of work as on date (**Annexure-IV**, **Pages 42-43**).

Further the committee has recommended to put Green Baroda Marble in place of Kota Stone at the entrance, Corridors and Mess Block, and anti-skid ceramic tiles in the bathroom instead of Kota Stone as per the design provided by Architecture Department of Punjab.

The matter is presented to the Building and Works Committee for consideration and approval of all the recommendations dated 1.12.2014 of planning, Execution and Inspection Committee and approval to release of Rs. 1.25 Crore to PWD (B&R).

#### Item19.4: Occupation of New Lecture and Tutorial Halls Building.

As per the recommendations of Construction Planning, Execution and Inspection Committee held on dated 21.08.2014 and subsequent approval of 18<sup>th</sup> BWC vide Agenda item No 18.6, the Full and Final payment of Rs 60, 50,649/- has been released to PWD (B&R), Ferozepur against the allotted work of Rs.627.05 Lacs for the Construction of New Lecture and Tutorial Halls including inventories of both Electrical and Public Health Fittings.

As per the recommendations of Construction Planning, Execution and Inspection Committee of dated 21.08.2014 and subsequent approval of 18<sup>th</sup> B&WC vide agenda item no 18.5, the Full and final payment of Rs..3600460/- for Civil Construction Work has been released to PWD (B&R), Ferozepur. The civil construction work of the said building was complete and accordingly before release of final payment, the building has been taken over by the institute on dated 23.09.2014 considering completion of civil construction work only (**Annexure-VIII, Pages 63**).

The institute has requested several times to concerned PWD authorities regarding supply of essential documents in respect of allotted work of New Girls Hostel, but till date they have not submitted the essential documents including Full and Final Bills of the executed work. The institute has also written to the Chief Engineer, PWD, Chandigarh regarding non settlement of bills of Electrical and Public Health utilities and requested to instruct the concerned authorities to supply the required documents to the institute to resolve the issue. # Item No 19.7:Installation of Sewerage Treatment Plant (STP) in the<br/>Institute.

As per directions of Punjab Pollution Control Board (PPCB) Patiala, the item was presented in the 16<sup>th</sup> Meeting of Building & Works Committee under Item No 16.6 to install a Sewerage Treatment Plant in the institute and as **per approved proceedings of 16<sup>th</sup> B & WC (Agenda item No 16.6) , it was decided to install the Sewerage treatment Plant (STP) from the PWD (Public Health ) as per Govt. Norms.** Accordingly the institute has written a letter to Executive Engineer , Water Supply and Sanitation , Division No 1, Ferozepur regarding installation of STP. Further the Water Supply and Sanitation department asked some rough data from the institute required to initiate the basic formalities for installation of STP (Annexure-X,pages-80) and the same was provided vide our letter No SBS/REG/EO/4633 dated 26-7-2014.(Annexure-X,pages-81).

Consequently the water Supply and Sanitation department, Ferozepur has submitted a rough cost estimate of Rs.225 Lacs approximately for the installation of STP in the institute.

The copy of the letter received from water Supply and sanitation Department, Ferozepur is placed at Annexure-X,pages-82.
