GENERAL TERMS & CONDITIONS (IMPORTANT)

Tenderers are requested to go through all the terms and conditions of Tender Notice/Tender Document carefully and to abide by the same. The under mentioned instructions should also be followed strictly while quoting the rates:-

- 1. <u>Please submit EMD 20,000/- in shape of DD alongwith tender bid</u>. No any other amount pending with the college shall be considered as EMD so the bidder has to submit EMD amount afresh along with the bid.
- 2. No interest will be paid on EMD amount.
- 3. All the equipments are to be installed as per the agreement within stipulated period. However considering the genuine reasons under force majeure circumstances, some extension may be given for a period if it does not affect the study/practical schedule of the college.
- 4. Rates quoted for all services are FOR SBSCET Ferozepur.
- 5. Inspection of all equipments to be used to provide RO water to the college, will be made at college time to time.
- 6. Rates of services should be quoted on supplier's letter pad with seal & signed neatly written of typed. Cutting/overwriting should be avoided.
- 7. **Performance Guarantee Bond** is also to be submitted in shape of Bank Guarantee or FDR for full period of agreement which shall be refunded after successfully completion of the contract **(10% of the contract value)** after execution of contract.
- 8. In case, the offer of contract is given to a successful tender bidder/firm and the firm does not execute it within the stipulated period mentioned in the order, the same firm may be blacklisted in the college record for future supplies.
- 9. Telegraphic/incomplete/Late tenders will be rejected. Last date and time for issue of tender document, receipt and opening is as shown above. Tenders will be opened in the presence of tenderers or their representatives who may wish to be present. In case this day happens a holiday or due to any administrative reasons, then the tenders will be opened on the next college working day as per same time schedule. The college will not responsible for any postal delay regarding this purchase.
- 10. The College will be at liberty to increase or decrease the quantity of the material to be ordered/supplied.
- 11. The tender shall be kept valid for acceptance for a minimum period of 90 (Ninety) days from the date fixed for opening of tenders. The tenders from those who have not kept the validity open as mentioned above shall be rejected.

- 13. All statutory deductions such as TDS etc./as per Govt. Rules, would be made by the college from payment to be made to the bidder.
- 14. Submission of copy of PAN card, permanent residency proof, copy of the first page of the bank account pass book.
- 15. <u>The Director</u> <u>reserves the right to accept/reject full or part of any tender, without assigning any reason</u> <u>whatsoever.</u>
- 16. Jurisdiction: This purchase is subject to the Jurisdiction of court in FEROZEPUR ONLY.
- **17.** The interested bidder has to inspect the site where the RO plant is to be installed.
- **18.** Any corrigendum / addendum / corrections, if any shall be published on the website only. The bidder should keep checking the website and follow accordingly.
- **19.** Any other term & condition made by the tender committee/indenting deptt. at the time of opening of the bids, shall be applicable on this contract.

For supply of R. O. Water to the Hostels

SPECIFICATIONS/TERMS & CONDITIONS

- The Contractor will install RO System of capacity 1000 LPH per hr. The contractor will provide 2 Manpower to provide purified water in each hostel and academic blocks through thermo cool water canes of capacity 20 ltr. Each. For this purpose the contractor will provide 50 water canes at his own cost. Rest of canes shall be purchased by each hostel as per the requirement. The location of the plant would be at the centre point of hostels Satluj Bhawan Beas Bhawan Ganga Bhawan & Yamuna Bhawan.
 The contractor will be responsible to supply purified water suitable for drinking.
- 2. The rates shall be quoted per month (inclusive of all taxes, charges etc.).
- 3. The period of contract will be three (3) years from the date of commencement of contract.
- 4. All infrastructures i.e. fitting of plant water purifying machinery its maintenance etc will be maintain by the contractor.
- 5. No extra maintenance charges except monthly charges shall be given.
- 6. Multiple connections of water supply at a single location shall be provided.
- 7. Building or any kind of civil work will be done by the Institution.
- 8. Electricity supply and payment of electricity bill will be borne by Institution.
- 9. The contractor shall keep the premises neat and clean and in hygienic condition.
- 10. The Contractor shall maintain a complaint book which will be made available to the students on demand.
- 11. The contract does not create any demise or tenancy of any other right in the said premises in favour of the contractor but it is only a license to use the said premises for the purpose specified above.
- 12. As agreed above the agreement shall be valid for three years. In case the Contractor fails to perform or observe any convents of conditions of this agreement or before the said date then at any time, the contract shall be cancelled

by the Institute by giving a notice of one month period personally or by post to the licensee or pasted on the outer door of the said premises.

- 13. If there remains excess purified water after making satisfactory supply to hostels and academic area, then the contractor may be allowed by the Director to supply it to the Campus Colony. The price charged from the residents of campus colony should be quite reasonable and at par with the existing market rates.
- 14. The Contractor shall be required to provide the service round the clock for full week.
- 15. Not to part with the possession of the said premises or any part thereof or allow anyone else to use the same for any business or purpose whatsoever.
- 16. Not to store any hazardous and or inflammable combustible gods or substance or articles in or around the said premises.
- 17. To remove himself from the said premises with all his belongings and leave it entirely vacant on revocation or termination of the contract.
- 18. The contractor will not cause annoyance or nuisance to the Institution, it is further agreed that the decision of the Director as to whether the Contractor or his employee has caused nuisance or annoyance shall be final, conducive and binding on the Contractor and the Contractor shall not question the said decision of the Director.
- 19. To provide the services in conformity with the quality, kind, rates of charges as specified by the Institution.

20. <u>The college authority can check the quality of water at any time and if it is</u> <u>found unsuitable for drinking purpose, strict action will be taken against the contractor.</u>

- 21. Not to admit any person in partnership or become partner of or agent or any one for the purpose of carrying on the said business.
- 22. The Original copy of the agreement shall be kept with the Institution and the Contractor shall keep the duplicate copy of the license.
- 23. The Contractor shall abide by the rules and regulations of Punjab Govt. while providing all the items of good and standard quality and this will be his responsibility to make payments of any type of taxes service taxes etc. to the Govt. as applicable from time to time.

All terms and conditions and specifications are accepted without any "DAVIATION".
