ITEM NO. 3.2 TO REPORT ACTION TAKEN ON THE DECISIONS OF THE SECOND MEETING OF THE FINANCE COMMITTEE.

Item No.2.4 Budget Estimate for the year 1996-97

Decision

The details of the budget were presented by the Principal. A balanced budget with proposed expenditure of Rs.746.60 lacs and an anticipated income of of Rs.746.60 lacs was presented. The expenditure consisted of i) Non-recurring: Rs.625.00 lacs and (ii) Recurring Rs.121.60 lacs. The major components of non-recurring comprised of land, buildings, machinery and equipment while salaries and contingencies largely formed the recurring expenditure.

The Committee discussed in detail the proposed budget estimates for 1996-1997 and resolved to approve the same.

Additional requirement of funds was discussed in detail. The Committee decided that demand for additional funds of Rs.329.29 lacs for the land claims, partial completion of priority buildings and development works, machinery and equipment, furniture, books, office equipment and hostel equipment be submitted to the Government in October/November 1996.

While discussing the details of the budget, a few suggestions were made as follows:-

- The engineering colleges should enhance their income by resorting to the following steps:
 - i) by constructing small shops on the campus and realisation of rent/contract.
 - ii) by promoting consultancy
 - iii) by organising extra classes for weak students on payment.
 - iv) by revision of fee structure

- A standard list of equipment required for setting up Health Centres in engineering colleges should be drawn up by collecting information from PHC, SHC and CHC. Sh.B.B.Bhasin, Deputy Registrar (C) was asked to collect the relevant information.
- The purchase procedures as provided in college bye-laws should be examined by DTE/IT 3. for improvements, if any.
- The internal telephone network cabling should be taken up at this stage of college development 4 so that EPABX facility could be provided.

The Budget as recommended by the Finance Commitee was placed in the second meeting of Action Board of Governors on September 24, 1996 and approved.

- i) Construction of small shops in College Campus is in progress and will be completed by June/July, 1997.
- ii) College earned a rent Rs.0.19 lakh from a milk booth on the campus.
- iii) Consultancy work will be taken up in due course of time when the college infrastructure is at reasonable level and senior faculty is in position.
- iv) College is arranging coaching classes to the students for CET exams.
- v) Revision of fee structure is not in the purview of the college. It is taken up at the level of the State Govt.
- vi) Information collected by the college is placed at Annexure II at on page No. 27-34 The work of dispensary is in progress, Medical Officer has joined his duties during March, 1997. The purchase of equipment will be made accordingly.
- vii) The quotations for installation of internal telephone, network, cabeling/EPABX facilities are collected and amount of Rs.20 lacs is proposed in the budget estimate of 1997-1998.
