It includes an amount of Rs.0.69 lac incurred on the repair of staff car which met with accident. A sum of Rs.0.15 lacs was recovered from the staff on account of transportation charges(private use)and Rs.0.46 lacs were received towards insurance claim for the car from United India Insurance Co.Ltd., Ferozepur.
