Item No. 4.3

Purchase of Simultaneous thermal Analyzer (DTA,DSC & TGA) for Material Science & Engg. Lab of Material Engg. Deptt.(Under MODROB Project Scheme) of Dr. A.K.Tyagi, sponsored by AICTE New Delhi.

The purchase order for this item had been sent to the firm. (Copy of the purchase order is placed at annexure B-1 page no.13).

Later on, an anonymous complaint had been received in this college, duly marked by the Technical Education Minister, Punjab, pointing out embezzlement in the purchase of said equipment (copy enclosed at annexure B -2 page no. 14 ).

Accordingly, this office had constituted a committee to probe into the alleged allegations. The inquiry report of the case has already been sent to the DTE&IT office for its consideration.

**Cancellation of purchase order of simultaneous Thermal Analyzer (DTA,DSC & TGA) for Material Science & Engg. Lab of Material Engg.Deptt.(Under MODROB Project Scheme) of DR.AK Tyagi, sponsored by AICTE New Delhi,**

As per decision of the 4<sup>th</sup> meeting of the Equipment and Stores Purchase Committee (agenda item no. 4.3), purchase order for above said item had been placed to M/s Spectronic Instruments, Mumbai . But anonymous complaint had been received in the college,duly marked by the Technical Education Minister, Punjab, pointing out some embezzlement in the purchase of the said equipment (copy enclosed at annexure B-2 page no. 14 ) . Subsequently, this office had constituted a committee to ~~probe into~~ the alleged embezzlement in the purchase of the equipment . The committee has pointed out several irregularities/procedural lapses in the purchase of the said equipment and recommended the cancellation of the purchase order of above said equipment. (observations and recommendations of the committee are placed at annexure B -4 page no.16 to 20 .

Since the firm has not supplied the equipment and payment has not been released to the firm till date, so there is no question of embezzlement of alleged funds that allegedly took place. The committee had again recommended that an expert committee may be constituted to pre inspect the said equipments of all the firms , so that funds received from AICTE may be utilised within time without avoiding the likely lapse of precious funds.

However, since there are so many procedural lapses, it is recommended that the order may please be cancelled and the college shall request for furthur extension in time to be taken from AICTE, so that the funds do not become time barred. So it is recommended that the order of the said firm may be cancelled.

The case is placed before the committee for final approval please.



Item No. 5.4 Purchase of (i) IR Spectrophotometer or FTIR Spectrophotometer.

For Research Lab (under R&D project Scheme of Dr. Sangeeta Sharma, sponsored by AICTE New Delhi was sanctioned for Rs. 6 Lakhs copy placed at annexure D-1 Page 22 to 24.

After opening of tenders these were evaluated by college committee. The comparative statement is available at annexure D-2 Page no. 25 to 26.

The purchase of equipment has been recommended for M/s Scope Enterprises, Karol Bagh, New Delhi. Whose offer has been found as per NIT. Copies of tender specifications of M/s Scope Enterprises is placed at annexure D-3 Page no. 27 to 30. Expenditure involved in said purchase will be Rs. 5,43,150/-
